One of the main goals of the Inclusive stone project is the integration of people with disabilities into the world of work and encouraging the development of skills and abilities through the stone sector.

At least 16% of the working-age population of the European Union are people with disabilities who need support in order to engage in work. Support starts from raising awareness among all entities involved in the stone industry.

People with disabilities represent a significant potential for contribution and development of the economy and the labor market. Only 50% of people with disabilities are employed, which is already an indication that the potential of people with disabilities is still largely underutilized. Therefore, it is crucial to respond to the needs of people with disabilities in order to enable them to better integrate into the labor market and participate in society.

In order to achieve the main goal of the project, a series of steps and activities will be implemented that will guarantee a good effect on the target group and a sustainable effect over time.

Raising awareness among companies, institutions, and small businesses about the employment of people with disabilities is an important part of the project's activities, as well as raising awareness in education itself.

The project activities also includes market research and the needs of employers in the stone sector, the creation of manuals, the creation of a VR game for learning safety at work, materials and devices for work in construction and masonry.
